  - Nov. 16 29 Like Sharefax Facebook page and share a #ShareKindness quote to be entered to win in a weekly drawing.
- 3. You may also enter by visiting sharefax.org, completing the online entry form and submitting it as instructed. One online entry only per person. Entry forms that are incomplete, lost, late, misdirected, incorrect, garbled, or incompletely received, for any reason, including by reason of hardware, software, browser, or network failure, malfunction, congestion, or incompatibility at web servers or elsewhere, will not be eligible.
