



Scholarship Application Requirements

A candidate for the 2021 Credit Union Scholarship must:

- Be or become a member of the Sharefax Credit Union. The applicant's accounts must be in good standing at the time of application. (The scholarship applicant must have a separate Sharefax membership in their name and under their social security number. Membership is established by opening a Savings Account with a minimum deposit of \$5.)
- Be a graduating high school senior, and be accepted as an entering full-time, first-year student at an accredited college or university; or a current college student.
- Complete the attached application and essay pages and return them to the Sharefax Credit Union on or before February 12, 2021. If you wish to have your scholarship application also submitted to the Cincinnati Area Credit Union Outreach Alliance (CACUOA) for their 2020 scholarship(s), you must complete all Cincinnati Chapter Forms & Essays and return all requested items by February 12, 2021.
- Selection of the recipient will be made by the Sharefax scholarship selection committee from a list of candidates. Selection is based on criteria established by the committee and approved by the Board of Directors. Recipient may receive this award in addition to any other awards or financial assistance received.

As a Sharefax Credit Union member, you are eligible for two scholarship opportunities!

This year, Sharefax Credit Union is awarding one \$2,000 scholarship and two \$1,000 scholarships for post-high school studies in the 2021-2022 school year. In addition, the Credit Union Outreach Alliance is awarding at least eight \$1,000 scholarships for the same purpose.

To qualify, you must be at least a senior in a local high school and plan to enroll in post-high school studies, including vocational, professional and academic studies, which are not limited to colleges and universities. Applicants may also be anyone who is obtaining an Associates or Bachelor Degree. **You yourself must be a primary member of Sharefax Credit Union to be eligible.**

By submitting this application, you will be considered for scholarships by both, Sharefax Credit Union and the Cincinnati Area Credit Union Outreach Alliance.
