## Find The Sharefax Christmas Elf Contest Rules

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN. The Find The Sharefax Christmas Elf website scavenger hunt contest ("Sweepstakes") is open to anyone in the United States. Employees, retirees, and agents Sharefax Credit Union ("Sharefax") ("Sponsor") (including their families and persons living in their households) and each of their parents and affiliates, agencies, distributors, and members of such employees' immediate families and individuals living in the same household with such employees, are not eligible to enter or win. Void where prohibited. By participating, entrants agree to these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to this Sweepstakes.

During the Sweepstakes Period, there will one (1) separate Prize drawing periods on the dates set forth in Section 3 below (each, a "Prize Entry Period"). All entries must be received by Sponsor by 11:59:59 p.m. ET of each Entry Period in order to be eligible as a weekly entry in the prize drawing. Each entry received that includes the correct answer will receive one (1) entry into the next prize random drawing. LIMIT ONE (1) ENTRY PER PERSON PER ENTRY PERIOD. Administrator's computer will be the official time clock for the Sweepstakes. Any attempt at Website or other alternative Internet entry is void.
